## **Camp dispersal**



#### Working definition:

Any action that attempts to remove or move all or part of the group of flying-foxes by either disturbing the animals or removing or modifying habitat.

#### Any edits?

Note: we are not focussing on relocations, which are a type of dispersal where the intended location of the dispersed bats is known or pre-selected.

### Background

Numerous camp managers in all states with FF are still investigating or are undertaking dispersals.

Includes:

- Relatively small camps (e.g. Colac few 1000 GHFF, 2019)
- High profile camps ~20 years ago (e.g. Melb Bot Gardens, 2000-2003, 30,000 GHFF)
- High profile camps recently (270,000 FF at Batemans Bay, 2016) And the list goes on.....

Reasons include massive increases in number of FF, new camps being established, aesthetic/cultural/recreational damage, etc

### **Objectives**

Re-visit the issues and management of dispersals and
